THREE ACCUSED FOR CONSPIRACY OF MURDER ARRESTED BY NR-I, CRIME BRANCH

- Trilochan Singh Wazir was murdered in 2021.
- Persons involved and present at scene of crime were arrested in 2021
- One accused is a businessman involved in multifarious businesses and is a well-known figure of Jammu.
- Two accused are in finance and real estate business.

INTRODUCTION:

A team of Northern Range-I, Crime Branch has arrested 03 accused who had conspired in murdering Sh. Trilochan Singh Wazir, Ex. MLC of Jammu & Kashmir in the year 2021.

INFORMATION:

On 09.03.2021, Sh. Trilochan Singh Wazir was found murdered in a flat situated at 2nd floor in Basai Darapur, Delhi. His dead body was found lying in decomposed state in the washroom of the locked flat. The deceased had a gunshot injury on his head. In this regard, a case vide FIR No. 557/2021 U/s 302/201/120B/174A/34 IPC & 25/27 Arms Act, PS Moti Nagar, Delhi was registered and investigation was transferred to Crime Branch.

During investigation, the following three accused persons were arrested in the case on the basis of CCTV footage, technical analysis and statements:

1. Rajender Chaudhary, age-33 years R/o Village-Gagore, PS Vijay Pur, District-Sambha, Jammu.
2. Balbir Singh @ Billa, 67 Years R/o Preet Nagar, Digiana, PS Gandhi Nagar, Jammu.
3. Harmeet Singh, 61 years R/o Sector-11, Guru Nanak Nagar, Jammu.

One accused namely Harpreet Singh Khalsa was absconding. The flat where the dead body was found was taken on rent by the absconding accused. He had hosted the deceased in his house on the pretext of facilitating him in obtaining his VISA and air tickets

for Canada, where the family of deceased was living. Initially, the motive for murder was disclosed as possible extortion from the family members of deceased. However, no ransom call was made. Since the main accused was absconding, the conspiracy behind the murder could not be established. IO Inspr. Satish Malik worked under the close supervision of ACP/NR-I, Sh. Vivek Tyagi, overall supervision of Sh. Vichitra Veer, DCP/Crime and Sh. S.D. Mishra, Jt. CP/Crime.

During the investigation, the main accused Harpreet Singh Khalsa was arrested and based upon his interrogation, technical analysis was done.

The persons connected with him in Jammu, after the murder, were examined. Based on his examination, and technical inputs, the following three accused persons have been arrested. They have been found involved in the conspiracy to murder Sh. Trilochan Singh Wazir.

1. Sardar Jagpal Singh, 51 Years R/o Guru Nanak Nagar, Jammu.
2. Harjinder Singh Raina, 71 Years R/o Singh Niwas Akali Kuwar Singh Nagar, Digina, Jammu.
3. Sudershan Singh Wazir, 67 Years R/o Trikuta Nagar, Jammu.

PROFILE OF ACCUSED:

1. Accused Sudershan Singh Wazir is a business man in Jammu and has business in Industries, Educational Institute and Petrol Pump etc. He is cousin of the deceased Sh. Trilochan Singh Wazir. He had rivalry with Trilochan Singh Wazir and Nagar Singh. Sh. Nagar Singh is a businessman in Jammu. The son of Nagar Singh had murdered the nephew of accused Sudershan Singh Wazir. Both Trilochan Singh Wazir and Nagar Singh were also arrested in a sensational Chopra Murder case of Jammu of 2006. In the year 2018, Trilochan Singh Wazir and Nagar Singh were planning to murder Sudershan Singh Wazir in Delhi. This came to the knowledge of accused Sudershan Singh Wazir through Harmeet Singh and Harpreet Singh. In retaliation, accused Sudershan Singh Wazir, Harjinder Singh Raina and Jagpal Singh succeeded in conspiring to murder Trilochan Singh Wazir in Delhi with the help of accused Harpreet Singh Khalsa, Harmeet Singh, Rajender Chaudhary and Balbir @ Billa.
2. Accused Harjinder Singh Raina is a resident of Jammu and at present he is in local politics of Jammu. He was earlier into finance and real estate business. He was a member of DGPC and was secretary in DGPC from 2015 to 2016.

3. Accused Sardar Jagpal Singh is a businessman involved in real estate/construction business in Jammu. He is presently cashier in DGPC, Jammu since 01.07.2022.

MOTIVE BEHIND THE MURDER:

The motive was a mixture of personal enmity, political and financial gains.
