

Out of the above 752 posts, 45 posts shall have to be earmarked for providing 6% Horizontal reservation to the candidates belonging to the Ex-Servicemen category, as per Explanation-A of rule 4 of J&K Reservation Rules, 2005, amended vide S.O 127 dated 20.04.2020.
