## Prohibitory Order Under Section 144 of Criminal Procedure Code, 1973

### ORDER

Whereas, the counting of votes for the General Elections to the Lok Sabha 2024 is fixed on the 4<sup>th</sup> June, 2024;

Whereas, there exists every apprehension of problems related to law and order, public peace, order and tranquility on the day of Counting.

Now, therefore, in order to maintain public peace, order and tranquility on the day of counting, **I, Om Prakash Bhagat, JKAS, District Magistrate, Rajouri** in exercise of the powers conferred upon me under section 144 Cr. P.C. do hereby prohibit as under:-

1. Procession and sloganeering of any kind shall not be allowed within the premises of the counting centres.
2. Use of P.A. System/loudspeakers and celebration by any political party or candidates shall not be allowed within the premises of the counting venue.
3. Carrying of sticks either with or without flags, lathis, processions or big gatherings within a radius of 100 Metres from the counting centres is also prohibited.
4. Bursting and throwing crackers on the roads and at public places is strictly prohibited on the day of counting.

Further, no victory procession/rallies or any sort of other allies/procession by any candidate/political parties shall be allowed without prior permission of the undersigned.


This order shall come into force with immediate effect and remain in force till 5<sup>th</sup> of June, 2024.

The order shall be applicable within the territorial jurisdiction of District Rajouri.
