Terms of Reference:-

- To ascertain the exact number of sanctioned Lecturer posts with reference to the figures reflected in the existing statutes/Recruitment Rules, the posts actually in position on the ground and the strength reflected in the Department's establishment budget.
- To assess the actual requirement of Lecturer posts, discipline- wise, on the basis of institutional needs.
- To examine and propose rationalization of posts of Lecturers with special emphasis on those subjects which are presently in demand in view of technological advancements and emerging academic requirements.
- To examine the requirement of posts in language subjects, keeping in view the need-based academic requirements and regional relevance.
- To identify and earmark posts for vocational subjects keeping in view their functional necessity and institutional requirements.

The Committee shall submit its report along with specific recommendations to the Government within **30 days** from the date of issuance of this Order.
